

Terms of Use

These Terms of Use govern your access to and use of the website www.creditmantra.in, operated by CreditMantra Solutions Private Limited (CreditMantra). By registering on the Website, you (User) agree to these Terms. Please also review our Privacy Policy, which forms an integral part of these Terms. If you do not agree to these Terms, do not use the Website or its Services.

These Terms are an electronic record under the Information Technology Act, 2000, and are generated by a computer system, thus do not require physical, electronic, or digital signatures.

1. Description and Acceptance of Services

1.1 Services Provided

We offer the following Services through the Website:

Access to information about financial products/services to help you understand your financial wellness.

Facilitation of financial products/services from banks and financial institutions.

Assistance in assessing your credit health and providing options to improve it, based on your chosen actions.

1.2 Additional Terms

For specific Services, you may need to accept additional terms ("Additional Terms"), which will be provided at the point of access. In case of any conflict, the Additional Terms will prevail for the specific Service.

1.3 Voluntary Participation

You acknowledge that availing of our Services is voluntary, and we provide them on a commercially reasonable effort basis.

1.4 Changes to Services

CreditMantra reserves the right to add, modify, or remove any Services or Website features at any time without prior notice.

1.5 Third-Party Partnerships

We may partner with third parties to facilitate certain Services, including KYC collection, credit assessment, and payment processing.

1.6 Intermediary Role

CreditMantra serves exclusively as an intermediary for the Products provided by third-party partners. We are not responsible for the Products themselves or any shortcomings in their delivery. It is the Partners' responsibility to ensure compliance with applicable laws regarding these Products, and we are not liable for any issues that may arise from them.

1.7 Fair Practices

CreditMantra is dedicated to maintaining fair practices and refrains from engaging in misleading advertising, unfair trade practices, or discriminatory behaviour towards Users. By using the Website, you acknowledge and accept these Terms and recognize CreditMantra's role as an intermediary in facilitating Services and Products.

License to Use

2.1 License Grant

Credit Health Program

Our credit health assessment service is available for a fee when you sign up and retrieve your Credit Information Report ("CIR") through our website. To proceed, you will need to provide personal information, including your CIR, which we will handle in accordance with our Privacy Policy. By using the Website, you grant us permission to access your CIR from authorized credit information companies ("CICs"). CreditMantra may utilize your CIR to evaluate your eligibility for various Products and may limit access to certain features or Services if your credit score is below a threshold set by us.

6.2 Role of CreditMantra

You acknowledge that CreditMantra is not a CIC; instead, the CIR is obtained from an authorized CIC on your behalf. The CIR will be provided to you on an "as is" basis without altering its content.

6.3 Information Accuracy

Any information displayed about your creditworthiness, credit score, or credit health is based on your CIR from a CIC. CreditMantra does not guarantee the accuracy or completeness of this information and is not liable for any consequences arising from your reliance on it.

6.4 Reporting Discrepancies

If you notice any discrepancies in your CIR or have related inquiries, please contact the relevant CIC, whose details will be provided in the Additional Terms.

6.5 Consent for CIR Access

By allowing CreditMantra to access your CIR:

You consent to us retrieving your CIR from CICs, which will be stored and used for up to six months, or until it is no longer needed for providing Services.

To continue receiving Services beyond six months, you may need to renew your consent. Logging into your Account will automatically renew your consent for continued Services.

If you wish to withdraw your consent or no longer require Services that depend on your CIR, you can do so by contacting us at Consent.withdrawal@creditmantra.co.in Upon withdrawal, we will cease relevant Services and may be unable to fulfill prior requests. [click here to withdraw consent](#)

During the consent period, CreditMantra may periodically access your CIR and related data to provide ongoing credit health assessment services.
